(Agree as condition of Registration)

CRRA Parental Authorization:

I, the parent/Guardian of the registering child, hereby give approval to participate in any and all activities of Cutten Ridgewood Recreation Association (CRRA) during the current season. I assume all risks and hazards incidental to the conduct of the activities and transportation to and from the activities. I do further hereby release, absolve, indemnify and hold harmless CRRA, the City of Eureka, Cutten Elementary School District, Eureka City Schools, the organizers, sponsors, or any of the supervisors appointed by them. In case of injury to my child, I hereby waive any and all claims against those noted above.

Player Team Assignment:

There is NO guarantee that players are placed with a requested team, coach, or other players. Sibling options are granted in the same division (based on age) when possible.

Refund Policy:

Refunds are not available. Once you have paid and registered the player is enrolled in the program. Uniforms, hats, and trophies are all ordered and cannot be returned.

Snack Bar Agreement:

I understand that it is my responsibility to work in the concession stand occasionally as defined in local rules.

Photo Release:

Photographs taken during the season may be used on our website, Facebook, and/or advertising material.

Medical Release:

I hereby authorize CRRA or its authorized representatives to consent to any emergency medical or surgical care that may be deemed necessary for my child registering, while under League supervision. This authorization will remain in effect from this day through this current year. I understand reasonable attempts will be made to contact me before use of this consent is made.

CRRA PARENT/GUARDIAN CODE OF CONDUCT

We must all constantly support and encourage fair play, player safety and sportsmanship. Parents are required to follow the CRRA of Conduct:

- * I will always be supportive of my child, their teammates, and coaches.
- * I will remember that every player on the team is a contributing player.
- * I will spread my encouragement equitably amongst the team.
- * I will allow all coaching during the games to be done by the coaches and not by parents, in the stands or behind the backstop.
- * I will convey coaching suggestions and complaints privately to the coaches before or after games.
- * I will never badger the other team or argue with their supporters.
- * I will not question the umpires' judgement.
- * I will demand a sport's environment for my child that is free of drugs, tobacco (all forms including electronic devices), and alcohol and will refrain from their use at all CRRA events. (Smoking, Tobacco, and Electronic devices are not allowed on fields, surrounding areas, or parking lot. Smoking is only permitted off school grounds.)
- * I will support all efforts to remove verbal and physical abuse from my child's sporting activities. Physical violence, taunting, or any action that may provoke physical violence, by anyone during a CRRA function, will be sufficient cause for the Board to exclude that person(s) from future participation or attendance at any CRRA game or activity.
- * I will encourage good sportsmanship by demonstrating positive support for all players, coaches, and umpires at every game, practice, or other CRRA events.
- * I will be responsible for the actions of my guests.
- * I will stay out of the dugout.
- * I will support the team and League by volunteering my services.

Parents and their guests who violate these rules may be disciplined at the game (told to leave) and/or required to appear before the CRRA Board of Directors. Violations may result in a variety of consequences, including parental bans from games or other league activities. Managers are responsible for their players and for controlling their stands. Disruptive parents who do not follow coaches, umpires or Board Members instructions may cause the Manager to be suspended or the umpire may cancel the game.
